## DUPAGE HOUSING AUTHORITY RESOLUTION NO. 2019-20 PHA Voluntary Transfers of Housing Choice Vouchers:

**BE IT RESOLVED** by the Board of Commissioners of the DuPage Housing Authority as follows:

- WHEREAS, the DuPage Housing Authority Board of Commissioners has been made aware of a possible *Voluntary Transfer of Housing Choice Vouchers* under PIH 2018-12; and
- WHEREAS, the transfer would occur between Maywood HA (IL054) and DuPage HA (IL101); and
- WHEREAS, the transfer is permanent and for the entire balance of Maywood Housing Authority's HCV program to DuPage Housing Authority's HCV program; and
- WHEREAS, DuPage Housing Authority must secure jurisdictional authority to administer the program in the Maywood Housing Authority geographic location; and
- WHEREAS, DuPage Housing Authority has the administrative capacity to administer the Maywood Housing Authority's program and currently administers the DuPage Housing Authority HCV program within a reasonable proximity of (8.4 miles); and
- WHEREAS, DuPage Housing Authority will continue the administration of the Maywood Housing Authority's program, which includes serving the same population, and the vouchers will continue to be unitized for their original intended purposes; and
- WHEREAS, DuPage Housing Authority is bound by fair housing requirements, including the responsibility to affirmatively further fair housing and to reduce racial and national origin concentrations; and
- WHEREAS, DuPage Housing Authority has a high Section 8 Management Assessment Program (SEMAP) performance designation and has complied with any corrective action plan to address any financial or program audit findings related to the HCV program; and
- WHEREAS, the DuPage Housing Authority Board of Commissioners agrees in principle with the transfer, subject to being held harmless by HUD and QAD for Maywood Housing Authority's financial liability related to its OIG audit and corresponding repayment debt.; and
  - WHEREAS, a Non-Disclosure Agreement has been signed between the two agencies; and
  - WHEREAS, a telephone conference call and visual site visit has occurred; and
- **WHEREAS**, the effective date of the transfer is targeted for January 1, 2020 or July 1, 2020; and

**WHEREAS**, DHA is committed to serving the residents of Maywood and from a satellite office within the community they reside.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE DUPAGE HOUSING AUTHORITY, in the exercise of its statutory and other powers as follows:

**Section 1. Incorporation of Recitals.** That the Recitals contained in the Preamble to this Resolution are incorporated herein as fully set forth.

**Section 2. Contract.** That the Voluntary Transfers of Housing Choice Vouchers between DuPage Housing Authority and Maywood Housing Authority is hereby approved and accepted.

**Section 3. Closing.** The Executive Director, Kenneth E. Coles, is hereby authorized and directed to sign all documents necessary to consummate the Voluntary Transfer of Housing Choice Vouchers under PIH 2018-12 from Maywood Housing Authority to DuPage Housing Authority.

Section 4. This Resolution shall be in full force and effect from and after its passage.
